Omnis Sterling Corporate Bond Investment Manager Market Review



The Columbia Threadneedle team has over 20 years' average experience and works with 15 credit analysts who cover almost 500 issuers globally, along with 20 high-yield analysts in the US and Europe and 150 fixed income professionals globally. Their approach to managing investment grade corporate bonds is based on high-quality, bottom-up fundamental research, including the construction of forward-looking detailed financial models on each corporate credit, which gives them the best chance of having insight versus the rest of the market.

Crucially, the team has managed credit portfolios through both bull and bear markets, including the 'era defining' financial crisis.

Attribution analysis shows that most of the relative risks and returns have been generated by issuer and security selection, which has meant the team has delivered strong relative and risk-adjusted returns over time.
